Description	Green tea infused with fudge flavours.
Product Code	CSB001 / CSP001
Ingredients	Green Tea (96.75%), Flavour (Chocolate flavour, Caramel flavour, Cream-caramel flavour, Vanilla flavour) (3.25%).
Notices	Contains Caffeine. Made in a factory that handles nuts, milk and dairy products.
Serving Suggestions	One biodegradable pyramid tea bag or 2-3 teaspoons per person. Allow to brew in hot water for 4-5 minutes. Serve black or with a dash of milk to enhance the fudge flavour. Enjoy hot or cold.
Origin of ingredients	China and Germany.
Storage	Store protected from light, at a temperature <22°C, humidity of <65% and in closed packaging.
Shelf Life	If stored dry, at a temperature <22°C, humidity of <65%, in closed packaging and away from light, the tea shelf life is at least 18 months. Maximum 4 years. Fluctuations in weight during storage period are possible and related to the natural properties of the raw material.
Declaration of Conformance	This product conforms to legal requirements of UK and EU Food Law, especially in regards to (EC) No 396/2005 Residue Level Decree, (EC) No 1881/2006 Contaminants in Foodstuffs, (EC) No 1334/2008 Flavouring Regulations effective at the time of delivery.
